In our modern world of fast moving images and bold colors we seldom take a moment to pause and look deeper at the form and rhythm of the world around us. The goal of this unique juried exhibition is to challenge artists to take this pause and explore beyond the realm of color into shades of gray from the deepest blacks to the brightest whites. Both digital and film based prints will be considered.

Eligibility & Conditions — please read carefully!

- All works must be original and not previously exhibited. Though not required, artists are invited to submit a statement with their work.
- In addition to new black and white works in either silver based or digital prints artists are encouraged to reach "back in time" and find a gem in any form; 35mm slide color or b&w negative. Refresh and represent those images as digital b&w prints.
- Artists may submit up to 5 entries. The juror decides the number of works selected for the exhibition (may range from 30-90 pieces).
- Entrants must be 16 years or older to participate.
- Artwork must be ready for hanging or installation. Framed pieces must have wire for hanging. Matted work without frames will not be accepted. Artists will be asked to install their piece if it presents special hanging requirements; for installation entries, artists must submit a detailed sketch including dimensions & special materials to be provided.
- Off-island artists must ship their entries to the Hui in expertly packed shipping boxes or wooden crates. Shipping is at the artist's expense and should be prepaid for return.

Non-Refundable Entry Fee:

Hui members: \$10 per entry

Non-members: \$55 for the first entry & \$10 for each additional entry

Sales: The Hui encourages artists to offer their work for sale. Commission is split 50/50 between the artist and the Hui. Checks will be mailed 4-6 weeks after close of the exhibition, provided a completed & signed W9 tax form is on file.

**Hui No'EAU is not responsible for the loss or damage of artwork and/or framing.
All accepted artwork must remain in the gallery for the duration of the exhibition.**
