## **Hui No'eu Annual Juried Exhibition 2013**

**January 5 - February 15**

**Members' Opening Reception:** Friday, January 4, 2013

This prestigious competition offers an opportunity to view current work of local & mainland artists in all media, including ceramics, printmaking, sculpture, photography, jewelry, digital imagery, fiber, painting, and wood. Guest juror Lauren C. Faulkner is a Art History graduate of the University of Hawaii at Manoa. In her words: "I gain great satisfaction from knowing that our talented artists of Hawaii are appreciated for their truly international reach, skill, and vision."

### **Eligibility & Conditions — please read carefully!**

- All works must be original, created with the theme in mind, created within the past two years, and not previously exhibited. Though not required, artists are invited to submit a statement with their work.
- Artists may submit up to 3 entries. The juror decides the number of works selected for the exhibition (may range from 30-90 pieces).
- Art in any medium or combination of media are eligible. However, the Hui and its jurors reserve the right to reject works due to toxic or dangerous materials, excessive size, weight or difficulty in presentation.
- Entrants must be 16 years or older to participate.
- Artwork must be ready for hanging or installation. Framed pieces must have wire for hanging. Matted work without frames will not be accepted. Artists will be asked to install their piece if it presents special hanging requirements; for installation entries, artists must submit a detailed sketch including dimensions & special materials to be provided.
- Off-island artists must ship their entries to the Hui in expertly packed shipping boxes or wooden crates. Shipping is at the artist's expense and should be prepaid for return.

### **Non-Refundable Entry Fee:**

*Hui members:* \$10 per entry

*Non-members:* \$55 for the first entry & \$10 for each additional entry

**Sales:** The Hui encourages artists to offer their work for sale. Commission is split 50/50 between the artist and the Hui. Checks will be mailed 4-6 weeks after close of the exhibition, provided a completed & signed W9 tax form is on file.

**Hui No'eu is not responsible for the loss or damage of artwork and/or framing.  
All accepted artwork must remain in the gallery for the duration of the exhibition.**
